Water Project Update

- As of April 30th, there are approximately 20 remaining scheduled in-home connections to be made.
 - The well abandonment portion of the project (Phase 3) continues and occurs outside of the home and residents do not need to be present during this work.
 - Workers will be coming back to the outside curb boxes one at the street and another close to your home to install a pre-fab concrete ring around the curb box to support and protect it from lawn mower and vehicle traffic.
- The Town of Cecilton is migrating to a new, more efficient billing system that should take care of some glitches that was were discovered when adding the Pearce Creek Water Project customers into the current system. We will see the change in the next billing cycle.
